Amended Guidelines for Underground Crossing and Right-Of-Way Lines

Pipelines, electric lines, phone lines, fiber optic lines or any other line running across county roads or adjacent to and in county road right of way shall meet the following guidelines as set by the Commissioners' Court of Reagan County, Texas.

- 1. Lines must be a minimum depth of 60 inches from the top of the bore and shall run through a metal conduit extending beyond county right of way. However, lines with a depth greater than 60 inches do not require a metal conduit.
- 2. The top of the bore shall be at least 60 inches beyond the lowest point of the county right of way at the crossing point.
- 3. Pipeline operators shall place a clearly identifying sign at the entrance and exit points of county right of ways.
- 4. All signs shall state the appropriate notice as required by OSHA and/or the DOT (Notice-Warning-Danger), the pipeline operator's name, the pipeline operator's 24 hour phone number and the content of the pipeline.
- 5. Pipeline operators shall bore under all county roads, whether paved or unpaved. At no times shall pipeline operators cut ditches across county roads.
- 6. Prior to construction of any line crossing and/or running in the county road right of way, approval must be given by Reagan County, through the individual commissioner or Commissioners' Court as a whole.
- 7. County cattle guards shall not be used as a conduit for a road crossing point for pipelines, etc.
- 8. At no time shall county regulations circumvent federal or state pipeline guidelines or laws.
- 9. Operator must contact a county supervisor before covering a ditch.
- 10. The county reserves the right to inspect, accept or reject road crossing construction.
- 11. Track vehicles must be hauled when crossing county roads.
- 12. Some leeway may be granted for existing lines. However, all lines (in use or abandoned) shall meet the marking standards required by the county and/or other regulatory agencies.
- 13. All new construction shall meet all listed guidelines.
- 14. Violators will be held responsible for all damages.
- 15. Individual commissioners may approve the proposed underground road crossing. If commissioner denies application, the applicant may appeal to the full Commissioners' Court of Reagan County, by requesting the item be placed on the agenda at a regular Commissioners' Court meeting.
