BID NOTICE

The Reagan County Commissioners are accepting sealed competitive bids for the purchase of crushed base and water for the remainder of the fiscal year 2026, March 23 – September 30, 2026.

NOTE: If you bid in October, your bid is still in effect. If you desire to change your October bid, send in new bid documents. The new bid will be in effect for the remainder of the fiscal year.

Sealed bids must be marked “Crushed Base” and/or “Water” and are due by 12:00 p.m. on Friday, March 22, 2026, in the Office of the County Clerk, 300 N. Plaza, P.O. Box 100, Big Lake, Texas 76932.

Sealed bids will be opened in Court at 9:05 a.m. on Monday, March 23, 2026.

The bidder must submit, along with the bid:

- A complete and fully executed Form 1295 Certificate of Interested Parties. (Form 1295 must be accessed online at www.ethics.state.tx.us). 1295 Contract ID: Crushed Base/Water 3.28.22.
- A complete and fully executed Form W-9. (Form W-9 is available online at www.irs.gov).

§ 262.027(e), Texas Local Government Code, allows the commissioners’ court to consider the pickup and delivery locations of the bidders and the cost to the county of delivering or hauling the material to be purchased in determining the lowest and best bid for a contract for the purchase of road construction material. The commissioners’ court may award contracts for the purchase of road construction material to more than one bidder if each of the selected bidders submits the lowest and best bid for a particular location or type of material.

In compliance with House Bill 1612, 66th Legislature, regular session, the County reserves the right to waive any formalities in bids or bidding. The County may accept any bid deemed to be advantageous.
